## **Annual Meeting Minutes**

The annual meeting of the Continental View Homeowner's Association was held at the Louisville Recreation Center on April 18, 2019. The meeting came to order at 7:40 pm.

#### In Attendance:

#### **Business:**

- John Helton, Treasurer, presented the actual 2018 expenditures and the 2019 proposed budget. After much discussion, the budget and dues were approved for 2019.
  - O Dues will increase by \$15 per year so that the annual dues will be \$365 for 2019.
  - The HOA will carry a deficit of \$3,935 for 2019.
- The following budget items were discussed.
  - Fence repairs/maintenance.
    - Repairs have been completed following the car accident. We hope to be reimbursed for the \$1000 deductible we paid to the insurance company.
    - Other scheduled fence maintenance was also completed.
  - o Tennis courts.
    - The HOA received \$13,700 from the insurance company to repair hail damage to the tennis courts. The repairs are scheduled for late spring.
    - The attending members voted to spend an additional \$1000 to paint pickle ball lines on both courts.
  - Hays Street median renovation.
    - The 2019 budget contains \$2,625 for completing the renovation. The grounds committee will create a landscaping plan for median that includes some new plants or shrubs.
- Board and Committee members were nominated and confirmed.
  - We did not have enough volunteers to fill the position of HOA president.
  - The HOA board can function with only four members; however, we run the risk of having to hire an outside company to manage the HOA if we continue to lack volunteers.
    This would be very expensive for all HOA members.
- Meeting postscript 4/30/2019
  - o Michelle Baker volunteered to be president of the HOA board.
  - An e-mail was sent to members who attended the annual meeting so they could record their vote for president.
  - o The voting members approved the appointment of Michelle Baker as president.
